Mayor Patrick Bates asked for any public comments, there were none.



Approval of November invoices. Motion to approve by Donald Gunter, second by Jimbo Quick Approved 6-0.


Motion to adjourn by Bruce Bentley, second by Donald Gunter. Approved 6-0.

REBUILD ALABAMA FY2021 GRANT APPLICATION


WHEREAS, the Town Council of the Town of Berlin, Alabama, has convened a special meeting at 7:00 PM on the 23rd day of November, 2020;

AND WHEREAS, grant applications must be submitted by November 30, 2020;


